

**LICENSE AGREEMENT
TERMS AND CONDITIONS
FOR
DOWNLOADING LICENSED CURRICULUM CONTENT**

By indicating acceptance of the terms and conditions, user (hereinafter referred to as “Licensee”), agrees to be bound by the terms and conditions of this License Agreement.

1. Term. The Agreement shall begin as of the date of last signature below and end upon its termination as provided herein (the “Term”).
2. Licensed Materials. The Licensed Materials consist of the educational curriculum developed by WDA, the Colorado Future Farmers of America Foundation (“COFFA”) and Colorado State University (“CSU”). Licensee acknowledges that WDA, COFFA and CSU have committed significant time and resources toward the creation of the Licensed Materials.
3. Grant of License. WDA hereby grants to Licensee a personal, non-exclusive, non-sublicensable, non-transferable license to use the Licensed Materials during the Term in connection with Licensee’s educational efforts to promote a better understanding of the dairy industry. No other use of the Licensed Materials is authorized hereby.
4. No Rights to Modify Licensed Materials. Licensee may not alter the Licensed Materials in any manner whatsoever.
5. Ownership. Licensee acknowledges that, as between WDA and Licensee, WDA owns all right, title and interest in and to the Licensed Materials and that it will do nothing inconsistent with such ownership. Licensee agrees that nothing in the Agreement shall give Licensee any right, title or interest in or to the Licensed Materials, other than the right to use the Licensed Materials in accordance with this Agreement. Licensee further agrees that it will not challenge or otherwise object to the title of the Licensed Materials at any time, whether during or after the Term. The provisions of this paragraph shall survive the termination of this Agreement.
6. Reports. Pursuant to monitoring the quality and usefulness of the Licensed Materials and Licensee’s compliance with the terms of this Agreement, and upon reasonable request by WDA, Licensee will provide a brief report answering questions provided by WDA related to Licensee’s use of the Licensed Materials. This report may be provided electronically or otherwise, as indicated in the WDA request.
7. Warranties. Licensee represents and warrants to WDA that (a) it has full legal right and authority to enter into the Agreement and perform its obligations contained herein without violating the rights of any third parties; and (b) it shall comply with all applicable laws, statutes, ordinances, regulations and rules in performance of its obligations under the Agreement.

WDA MAKES NO EXPRESS OR IMPLIED REPRESENTATIONS OR WARRANTIES AS TO MERCHANTABILITY, FITNESS FOR ANY PARTICULAR PURPOSE OR USE BY

LICENSEE, NON-INFRINGEMENT, NON-INTERFERENCE, REGULATORY APPROVAL, OR ACCURACY WITH RESPECT TO THE LICENSED MATERIALS.

8. Indemnification by Licensee. Licensee agrees to indemnify, defend and hold harmless WDA, COFFA and CSU, and their respective officers, directors, employees and representatives, from and against any and all third-party claims arising out of or made in connection with Licensee's use of the Licensed Materials. The provisions of this paragraph shall survive the termination of this Agreement.

9. Limitation of Liability. Notwithstanding any other provision in this Agreement, WDA, COFFA and CSU shall not be liable for any special, indirect, incidental, punitive, or consequential damages, including loss of profits, arising from or related to a breach of this Agreement or any use of the Licensed Materials even if WDA, CSU or COFFA have been advised of the possibility of such damages. The provisions of this paragraph shall survive the termination of this Agreement.

10. Termination. This Agreement may be terminated (a) upon 180 days prior written notice by either party; or (b) immediately upon notice by WDA if Licensee breaches any term of this Agreement or, in the reasonable opinion of WDA, misuses the Licensed Materials in a manner which detracts from the value of the Licensed Materials to WDA, COFFA or CSU. Upon termination of the Agreement, Licensee's license to use the Licensed Materials immediately ends, and at WDA's option, Licensee shall promptly return or destroy any copies of the Licensed Materials.

11. Notices. All notices and reports to be given hereunder shall be sent by certified mail, return receipt requested, or by express mail or other overnight courier, with return receipt requested. If to Licensee, to the address provided below or online through the downloading process. If to WDA, to:

12. No Assignment. This Agreement may not be assigned by Licensee without the prior written approval of WDA.

13. Governing Law and Consent to Jurisdiction. The terms and provisions of the Agreement shall be interpreted in accordance with and governed by the laws of the State of Colorado without regard to its conflict of law principles, and the state and federal courts in Colorado shall have exclusive jurisdiction to resolve any dispute which may arise between the parties.

14. Miscellaneous. This Agreement may only modified by means of a written instrument signed by both parties. The failure of either party to enforce or the delay by either party in enforcing any of its rights shall not be deemed a continuing waiver or a modification of this Agreement. If a court of competent jurisdiction shall declare any part of the Agreement invalid

or unenforceable, it shall not affect the validity of the balance of the Agreement. This Agreement constitutes the complete understanding of the parties with respect to the Licensed Materials and supersedes any prior agreements, whether written or oral. The parties are independent contractors, and as such, neither party shall hold itself out to be an employee or agent of the other party. This Agreement shall be binding upon and inure to the benefit of the parties and each party's permitted successors and assigns.
